

Indian equity markets declined due to persistent concerns over U.S. fiscal challenges and renewed selling by foreign institutional investors (FIIs). Additionally, signs of moderating corporate earnings growth, elevated valuations, delays in finalizing the India-U.S. trade agreement, and rising COVID-19 cases across Southeast Asia prompted profit booking at higher levels after two consecutive days of gains.

Marwadi Chandarana Intermediaries Brokers has finalized an agreement to obtain a 75% ownership in the non-banking financial entity TruCap Finance, involving an investment of Rs. 207 crore. This investment comprises a combination of capital infusion via the preferential allotment of equity shares and convertible warrants, along with a secondary acquisition of 3.68 crore shares from the current promoter group of TruCap.

SBI Life Insurance and Vidyaniti LLP have acquired a 4.25% stake in National Highways Infra Trust for Rs. 1,100 crore through an open market transaction, while NHAI has divested 8.24 crore units in the Trust. Both entities collectively acquired a total of 8.24 crore units, which corresponds to a 4.25% stake. SBI Life Insurance Company purchased over 3.74 crore units, equating to a 1.93% holding in NHIT.



## Nifty 50 Earnings Yield Vs 10 Year Gsec Yield







### Securities Transaction Tax

Definition: Securities Transaction Tax (STT) refers to the tax levied on transaction (purchase or sale) of securities listed on the Indian stock exchange. Such securities include equity shares, derivatives and equity-oriented mutual fund units. The rate is specified by the Central Government from time to time.



### Explanation

STT is levied at the rate of 0.100% on purchase or sale of equity shares in a company, where such contract is settled by the actual delivery or transfer of such share or unit. However, for sale of a unit of an equity-oriented fund, where such contract is settled by the actual delivery or transfer of such share or unit, the rate has been revised to 0.001% with effect from June 1, 2013. The same shall be borne by the seller. Meanwhile, the rate of STT is 0.025% for sale of equity shares or a unit of equity-oriented fund, where such contract is settled other than by the actual delivery or transfer of such share or unit.
